At no time may ERPConnect Services be used by non-employed individuals of your organization for any purposes - nor may ERPConnect Services be distributed to any place outside your organization.

Core License: You are granted a license for all developers (individuals) of your company and contractors that you authorized to use the software on your company's behalf to use ERPConnect Services Core functions and features of the ERPConnect Service Core Runtime and the WebService Designer component on one online tenant. At no time may ERPConnect Services Core be used by non-employed individuals of your organization for any purposes - nor may ERPConnect Services Core be distributed to any place outside your organization.

Nintex Edition:

- The licensing is required both for on-premises and cloud environments separately.

 Components on one online tenant. All Nintex related features including
 business content are included in this license.
 At no time may ERPConnect Services Core be used by non-employed individuals
 of your organization for any purposes nor may ERPConnect Services Core be
 distributed to any place outside your organization.

Source Code License: This includes all rights and responsibilities associated with the Server License as well as a copy of the commented source code and the rights to create your own build for your business needs. You do not have rights to redistribute the source code to 3rd parties and you are legally responsible for maintaining its secrecy. You do not have rights to sell the build result as a component or redistribute in any way as a standalone product. The source code copy will not contain any licensing and code signing logic to protect future and current products of Theobald Software GmbH Components.
